## Nurse Aggrement Contract

This **Nurse Contractor Agreement** is made and entered into on this day by and between: Jaasim Home Healthcare, LLC., a State corporation, located at 252 W College Ave Apt 104 York, Pa. 17401.and **contractor's Full Name**, a licensed registered nurse, residing at Contractor's Address ("Contractor").

### RECITALS

WHEREAS, the Agency is engaged in providing home care services to clients, and the Contractor is a licensed registered nurse with expertise in providing nursing care services;

WHEREAS, the Agency desires to engage the Contractor to provide nursing services to clients in accordance with the terms and conditions set forth in this Agreement; NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

## 1. ENGAGEMENT OF CONTRACTOR

The Agency hereby retains the Contractor to perform nursing services as described herein, and the Contractor agrees to provide such services on an independent contractor basis, not as an employee of the Agency.

## 2. SCOPE OF SERVICES

The Contractor shall provide the following services to the Agency's clients:

- Assess and evaluate patients' health conditions and needs.
- Develop and implement nursing care plans.
- Administer medications and treatments as prescribed.
- Monitor and document the patient's health status.
- Collaborate with other medical professionals to ensure coordinated care.
- Provide patient and family education on health management.

- Perform other duties related to nursing care as agreed upon by the Agency and Contractor.

These services shall be provided in accordance with the nursing standards of care, applicable laws, and regulations.

### **3. INDEPENDENT CONTRACTOR STATUS**

- The Contractor is an independent contractor and not an employee of the Agency.
- The Contractor shall be responsible for all taxes, including federal, state, and local income taxes, social security taxes, and other obligations arising from compensation received under this Agreement.
- The Agency shall not withhold any taxes or provide any paid time off, or retirement benefits) to the Contractor.
- The Contractor shall not be entitled to any of the Agency's employee benefits or protections under any employment laws, including but not limited to workers' compensation, unemployment insurance.

### **4. COMPENSATION**

The Contractor shall be compensated at a rate of \$70.00 Amount per hour for the services rendered under this Agreement, payable weekly based on timesheets submitted by the Contractor and approved by the Agency.

The Contractor agrees to submit detailed records of services provided to clients, including the hours worked, to the Agency for payment. Payments will be made within [5] days business days following the submission of an invoice.

### **5. TERM AND TERMINATION**

- **Term:** This Agreement shall commence on Start Date and continue until End Date unless terminated earlier as provided herein.
- **Termination by the Agency:** The Agency may terminate this Agreement at any time, with or without cause, by providing [30] days' written notice to the Contractor.
- **Termination by the Contractor:** The Contractor may terminate this Agreement at any time by providing [30] days' written notice to the Agency.
- **Immediate Termination:** Either party may immediately terminate this Agreement in the event of material breach, including but not limited to breach of confidentiality, failure to perform services, or violation of applicable laws or regulations.

Upon termination of this Agreement, the Contractor shall promptly return any Agency property and cease using any Agency-related materials or information.

### **6. CONFIDENTIALITY**

- The Contractor agrees to maintain strict confidentiality regarding any and all client information, including but not limited to personal health information (PHI), medical records, treatment plans, and financial details.
- The Contractor agrees not to disclose, use, or permit the use of such confidential information except in the course of performing the services described in this Agreement, and in compliance with applicable confidentiality laws, including the Health Insurance Portability and Accountability Act (HIPAA).

## **7. COMPLIANCE WITH LAWS**

The Contractor shall comply with all applicable federal, state, and local laws and regulations, including those relating to licensing, health care, patient confidentiality, and labor practices. The Contractor represents that they hold a valid and active nursing license and will provide documentation of the same upon request by the Agency.

## **8. INSURANCE**

The Contractor agrees to maintain professional liability insurance, with coverage of no less than \$[Amount] per occurrence, for the duration of this Agreement. The Agency may request proof of such insurance at any time.

The Contractor shall indemnify and hold harmless the Agency, its officers, employees, and agents, from any liability, loss, or damage arising from the Contractor's performance or failure to perform under this Agreement.

## **9. NON-SOLICITATION**

The Contractor agrees that during the term of this Agreement and for 1 year following its termination, the Contractor will not directly or indirectly solicit, recruit, or hire any employee or independent contractor of the Agency for employment or engagement with any competing business.

## **10. DISPUTE RESOLUTION**

In the event of any dispute or disagreement arising under or in connection with this Agreement, the parties agree to attempt to resolve the matter amicably through negotiation. If a resolution cannot be reached through negotiation, the dispute shall be submitted to binding arbitration in accordance with the rules of Arbitration Institution in Location. The decision of the arbitrator shall be final and binding.

## **11. ENTIRE AGREEMENT**

This Agreement represents the entire understanding between the Agency and the Contractor concerning the subject matter hereof and supersedes all prior discussions, negotiations, and agreements, whether written or oral. Any modifications or amendments to this Agreement must be in writing and executed by both parties.

**12. SEVERABILITY**

If any provision of this Agreement is determined to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

**13. GOVERNING LAW**

This Agreement shall be governed by and construed in accordance with the laws of the State of State, without regard to its conflict of laws principles.
